

2018 MADaboutvolleyball Camp at JAMES MADISON UNIVERSITY!

REGISTRATION

Advanced Camp: Saturday, July 7th

Campers check in at **Hoffman Hall** between 9:30-11:30A. Campers must be prepared to participate in skills testing at **Godwin** between 10:00-12:00P (groups will be leaving **Hoffman Hall** every twenty minutes, starting at 10:00A, to walk to **Godwin Hall**). Lunch will be provided and instruction starts at 2P.

***Skills Testing:** We do not have time to evaluate each camper for an extended period of time during this quick testing period. Our goal is to have each camper through in thirty minutes. Please bear with us as we try our best to get each camper on the right team. We evaluate campers based on technique, skill and results. We try to make teams age appropriate, as well. During testing campers will be asked to warm-up, serve, pass, set and attack. If you would like to be on the same team as a friend, please tell the coach in charge of Skills Testing at the end. Both campers will be placed on the team of the camper that tested the lowest.*

Position Specialty Camp: Wednesday, July 11th

Campers check in at **Hoffman Hall** between 9:00-10:00A, instruction starts at 10:30A in **Godwin Hall**. Campers will initially be divided into groups by position for the start of instruction, and then will be evaluated further and divided into groups by ability level according to number of campers.

HEALTH & RELEASE OF LIABILITY FORMS

You must bring the completed Health and Release of Liability forms with you to Camp (pages 3 & 4 of this packet). **CAMPERS CANNOT BE ADMITTED WITHOUT THESE TWO FORMS.** Health services include an athletic trainer on-site. Drugs, alcoholic beverages and cigarettes are strictly forbidden and constitute, along with general misconduct, grounds for immediate dismissal from camp without camp credit.

CHECK-OUT

Advanced and Team campers will participate in the final camp tournament on the last day. The Tournament takes place in **Godwin Hall** and the **Recreation Building (UREC)**. Parents are invited to attend at any time. Overnight campers check out from **Hoffman Hall**. Extended day campers leave directly from **Godwin Hall**.

Advanced Camp: Tuesday, July 10th

Final matches take place between 1:00-3:15pm, campers check out at 3:30pm.

Position Specialty Camp: Thursday, July 12th

Playing ends at 4:15pm, campers check out at 4:30pm.

ROOM KEY & MEAL CARD DEPOSITS

James Madison University requires a room key deposit of **\$20** and a meal card deposit of **\$10**. Please bring **two** checks made out to **MADaboutvolleyball** for **\$20** and **\$10** to check-in and we will hold the checks for you until the key and meal card are returned on the last day of camp. Once the key and meal card are returned, we will shred your checks.

ROOMMATES

Campers stay in dorms on campus **TWO** per room, and are assigned by age and roommate requests. If you have a roommate request, and have not already given it to us, please do so **as soon as possible**. **All requests cannot be guaranteed.** If you don't have a roommate request, every effort will be made to place you in a room with someone near your age. It will be a great opportunity to meet someone new! Campers are under constant supervision as coaches/staff stay in the dorm with them while they are at camp.

EXTRA NIGHT STAY, JULY 10TH

For those campers staying the Extra Night on July 10th there will be a meeting in Hoffman Hall at 4:30P after camp ends. Family is allowed to take campers off campus as long as it is cleared with the JMU staff at this meeting (need parent approval). We will go to dinner at 5:00P and go to the movie theater on campus that evening at 7:00P.

SPENDING MONEY

Campers can purchase snacks, drinks, t-shirts, sweatshirts, headbands, JMU water bottles, etc. at the camp store. We will also have a pizza night (\$10/large pizza). CASH/CHECK ONLY

AUTOMOBILES ON CAMPUS

All vehicles driven to camp and retained during camp must be registered at check-in. **All** keys to these cars must be turned into the Camp Director. Please notify staff that you have a car when you come through registration to get your parking pass (otherwise you will be ticketed by JMU Parking Services). You will be parking in K Lot.

COMMUNICATION IS ENCOURAGED

We encourage communication with home. Campers are permitted to call their family and friends during breaks and after hours. If you need to reach your child for an emergency, please call 540-478-3330. If campers have any concerns, such as homesickness, illness or injury, please ask them to talk to their Coach first. We are committed to making this a great experience for your child and want to deal with issues immediately.

CANCELLATIONS

If you have to cancel prior to camp for any reason, we will issue you a camp credit for **MADaboutvolleyball** for all camp fees paid, valid through 2019.

Your camp credit is transferable to a family member.

EXTENDED DAY CAMPER INFORMATION FOR ADVANCED AND POSITION CAMPS

We are very excited that you are going to be joining us this summer at the **MADaboutvolleyball** camp at JMU. Here are some important facts that apply to **extended day campers only**.

WHEN DO I GET TO CAMP?

All Extended Day Campers register at the same time as everyone else in Hoffman Hall. Please see **REGISTRATION** on the first page for details.

WHAT IS MY DAILY SCHEDULE?

You will receive your schedule on the first day of camp. After you've eaten breakfast at home, you should arrive at the **volleyball courts 10 minutes prior to the start of your first session (except Day 1 when you register with everyone)**. You will join the resident campers for both lunch and dinner. Extended day campers depart after the evening session. **Departure each evening is between 8:00-9:00P at Godwin Hall.**

2018 MADABOUTVOLLEYBALL CAMP RELEASE OF LIABILITY FORM – PLEASE READ BEFORE SIGNING

In consideration of my minor child/ward _____ (“my child”) being allowed to participate in this sport camp program, its related events and activities, I, the undersigned, acknowledge, appreciate, and agree that:

1. The risk of serious injury from the sports activities involved in this program is always present due to the nature of the sport(s): and
2. FOR MYSELF, SPOUSE AND CHILD, I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my child’s participation; and
3. I willingly agree to comply with the program’s stated and customary terms and conditions for my child’s participation. If, however, I observe any unusual significant concern in my child’s readiness for participation and/or in the program itself, I will remove my child from participation and bring such to the attention of the nearest official immediately; and
4. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE, INDEMNIFY, AND HOLD HARMLESS the camp, Madaboutvolleyball, their officers, official agents, and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and, if applicable owners and lessors of premises used for activity (“Releasees”). WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, OR LOSS OR DAMAGE TO PERSON OR PROPERTY, regarding my child and/or arising from his/her activities, WHETHER ARISING FROM NEGLIGENCE OF THE RELEASEES OR OTHERWISE, except for willful misconduct, or otherwise to the fullest extent of the law.

AGREEMENT TO ARBITRATE DISPUTES

IN THE EVENT OF ANY DISPUTE PERTAINING TO ANY PROVISION OF THIS AGREEMENT, OR PERTAINING TO THE SERVICES RENDERED PURSUANT TO THIS AGREEMENT, OR IN ANY WAY RELATED TO ATTENDANCE AT THIS CAMP, INCLUDING ANY CLAIM FOR PERSONAL INJURY OR OTHER LOSS, INCLUDING ANY CLAIM AGAINST MADABOUTVOLLEYBALL, ANY DIRECTOR, EMPLOYEE OR AGENT OF THE CAMP OR OF ANY FOREGOING ENTITY, EACH PARTY HERETO AGREES TO SUBMIT TO BINDING ARBITRATION TO RESOLVE SUCH DISPUTES, BY CLAIM FILED. In the event either party to this agreement incurs any expense as a result of the other party’s failure to comply with any provision of this agreement, the non-complying party shall be liable for reimbursement of any and all such expenses or attorney fees directly or indirectly related to failure to comply. In the event any legal action or proceeding occurs which is in any manner related to or pertaining to this agreement, attempting to challenge in a non-arbitral forum such as a court of law the validity or application of this agreement, the party who substantially prevails in that court or non-arbitral proceeding shall be entitled to receive reasonable costs of such action or proceeding including attorney’s fees. In the arbitration itself, each party shall bear its own attorneys’ fees. The following disclosures are intended to help you thoroughly understand the significance of agreeing to arbitrate any controversy, or claim, or issue in any controversy or claim which may arise between the undersigned client and the attorney.

- A. ARBITRATION SHALL BE FINAL AND BINDING ON THE PARTIES.
- B. THE PARTIES HERETO ARE WAIVING THEIR RIGHT TO SEED REMEDIES IN COURT, INCLUDING THE RIGHT TO JURY TRIAL.
- C. PRE-ARBITRATION DISCOVERY IS GENERALLY MORE LIMITED THAN AND DIFFERENT FROM COURT PROCEEDINGS.
- D. THE ARBITRATOR’S(S) AWARD IS NOT REQUIRED TO INCLUDE FACTUAL FINDINGS OR LEGAL REASONING AND ANY PARTY’S RIGHT TO APPEAL OR TO SEEK MODIFICATION OF RULINGS BY THE ARBITRATOR(S) IS STRICTLY LIMITED.
- E. THE ARBITRATOR OR PANEL OF ARBITRATORS WILL TYPICALLY INCLUDE AN ATTORNEY OR JUDGE, ACTIVE OR RETIRED.

BY SIGNING BELOW YOU ARE SIGNIFYING UNDERSTANDING AND ACCEPTANCE OF THE PROVISIONS OF THIS AGREEMENT. I hereby certify that the above-mentioned participant is in good health and fully able to participate in all activities of the camp.
